## 2017 ASM VENDOR FEES

### Weekly Vendor Fees

Full Time Vendors:	\$25 minimum or 10% gross, whichever sum is greater.
PartTime Vendors:	\$30 minimum or 10% gross, whichever sum is greater.
Floater:	\$35 minimum or 10% gross, whichever sum is greater.
Cruise Ship Vendors:	\$35 minimum or 10% gross, whichever sum is greater.

**Full** time vendors must vend 19 or more times. An agent can be used up to three times.

**Part** time vendors must vend 11 or more times. An agent can be used once.

**Floater**s are vendors who participate fewer than 11 times. No agent can be used.

**Cruise Ship Vendors:** To participate you must complete this form and pay the annual vendor application fee indicated below even if you don't plan on vending at the regular seasonal market. A separate sign-up form is available to register for specific cruise dates.

**Returning Vendor Application Deadline:** March 13, 2017 to maintain your preferred location or product placement. Annual Registration Fee must accompany application.
